# NOTICE OF INTENTION TO MAKE A GATING ORDER

### **SECTION 129A HIGHWAYS ACT 1980**

# **ALLEYWAYS IN THE PROVIS ROAD AREA, CHORLTON**

Manchester City Council ("the Council") proposes for the purposes of reducing crime and antisocial behaviour to make an Order preventing anyone, other than those persons specified in the Order, from using the alleyways described in Schedule 1 to this Notice ("the Highways"). The Highways are shown as '1', '2', '3', '4' and '5' on the Order plan. The restriction will apply at all times.

The Order will exempt any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, emergency services personnel, statutory undertakers and utility providers from the restriction.

An alternative route for pedestrians and vehicles is available by using the existing highways of Higson Avenue, Belwood Road, Provis Road and Copgrove Road as shown by dotted lines on the Order plan. A draft of the proposed Order is set out in Schedule 2 to this Notice.

## Alleyways to be gated

- 1) The alleyway situated to the side of 19 21 Higson Avenue over its full length of 20 metres and for its full width. Shown marked '1' and edged in black on the Order plan.
- 2) The alleyway situated to the side of 35 37 Higson Avenue over its full length of 20 metres and for its full width. Shown marked '2' and edged in black on the Order plan.

- 3) The alleyway situated to the rear of 1 51 Higson Avenue and the rear of 2 52 Provis Road over its full length of 119 metres and for its full width. Shown marked '3' and edged in black on the Order plan.
- 4) The alleyway situated to the side of 20 22 Provis Road over its full length of 20 metres and for its full width. Shown marked '4' and edged in black on the Order plan.
- 5) The alleyway situated to the side of 36 38 Provis Road over its full length of 20 metres and for its full width. Shown marked '5' and edged in black on the Order plan.

# DRAFT GATING ORDER - SECTION 129A HIGHWAYS ACT 1980 CITY OF MANCHESTER (ALLEYWAYS IN THE PROVIS ROAD AREA, CHORLTON) GATING ORDER 2011

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

- 1. Except as provided in Article 2 to this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black on the plan annexed to this Order and described in the Schedule to this Order at any time.
- 2. The restriction in Article 1 to this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
- 3. Barriers will be installed, operated and maintained to the rear of 52 and 2 Provis Road and to the sides of 36/38 and 22/20 Provis Road and to the sides of 35/37 and 19/21 Higson Avenue. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 245 7850.
- 4. An alternative route for pedestrians and vehicles is available by using the existing highways of Higson Avenue, Belwood Road, Provis Road and Copgrove Road as shown by dotted lines on the Order plan.
- 5. This Order shall take effect on the date hereof.

1) The alleyway situated to the side of 19 – 21 Higson Avenue over its full length of 20 metres and for its full width. Shown marked '1' and edged in black on the Order plan.

- 2) The alleyway situated to the side of 35 37 Higson Avenue over its full length of 20 metres and for its full width. Shown marked '2' and edged in black on the Order plan.
- 3) The alleyway situated to the rear of 1 51 Higson Avenue and the rear of 2 52 Provis Road over its full length of 119 metres and for its full width. Shown marked '3' and edged in black on the Order plan.
- 4) The alleyway situated to the side of 20 22 Provis Road over its full length of 20 metres and for its full width. Shown marked '4' and edged in black on the Order plan.
- 5) The alleyway situated to the side of 36 38 Provis Road over its full length of 20 metres and for its full width. Shown marked '5' and edged in black on the Order plan.
